AN ORDINANCE ADOPTING AND RECOGNIZING THE 442 CULTURAL PROPERTIES IN THE CITY OF MANILA PREPARED BY THE DEPARTMENT OF TOURISM, CULTURE AND ARTS OF MANILA IN COMPLIANCE WITH THE REQUIREMENT OF THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT FOR THE SEAL OF GOOD LOCAL GOVERNANCE

EXPLANATORY NOTE

The State shall foster the preservation, enrichment and dynamic evolution of a Filipino culture based on the principle of unity in diversity in a climate of free artistic and intellectual expression. The Constitution likewise mandates the State to conserve, develop, promote and popularize the nation's historical and cultural heritage and resources, as well as artistic creations. It further provides that all the country's artistic and historic wealth constitutes the cultural treasure of the nation and shall be under the protection of the State, which may regulate its disposition. In the pursuit of cultural preservation as a strategy for maintaining Filipino identity, the State shall pursue the objective to protect, preserve, conserve and promote the nation's cultural heritage, its property and histories, and the ethnicity of local communities.

The National Commission for Culture and the Arts (NCCA), as part of its mandate is requiring each local government unit, through their cultural offices, maintain an inventory of cultural properties under its jurisdiction and shall furnish the NCCA a copy of the same. Cultural agencies and local government units concerned shall continuously coordinate in making entries and in monitoring the various cultural properties in their respective inventory.

The Department of Tourism, Culture and Arts of Manila (DTCAM) has been submitting list of cultural properties to the NCCA and for this year, has chosen 442 cultural properties which is a requirement for the Seal of Good Local Governance, to be adopted and recognized as the City of Manila's inventory of Cultural Properties, hence, this Ordinance.

Be it ordained by the City Council of Manila, in session assembled, *THAT*:

SECTION 1. The list of local cultural properties prepared by the Department of Tourism, Culture and Arts of Manila (DTCAM), submitted to the National Commission for Culture and the Arts (NCCA) for inclusion in the Philippine Registry of Cultural Property (PRECUP) is hereby adopted and recognized as the City of Manila's official inventory consisting of 442 cultural properties.

SEC. 2. The list shall be supplemented and updated from time to time and be submitted to the NCCA for recognition in compliance with the Department of the Interior and Local Government as requirement for the Seal of Good Local Governance.


SEC. 3. This Ordinance shall take effect immediately upon its approval.

This Ordinance was finally enacted by the City Council of Manila on December 6, 2022.


