AN ORDINANCE AUTHORIZING SUPPLEMENTAL BUDGET NO. 1 FOR THE VARIOUS REQUIREMENTS OF THE CITY OF MANILA UNDER PERSONAL SERVICES, MAINTENANCE AND OTHER OPERATING EXPENSES AND CAPITAL OUTLAY IN THE TOTAL AMOUNT OF SEVENTY-FOUR MILLION ONE HUNDRED NINE THOUSAND FIFTY-SEVEN PESOS (PHP. 74,109,057.00) AND FOR OTHER PURPOSES

EXPLANATORY NOTE

Section 16 of Republic Act (R.A.) No. 7160 or the Local Government Code (LGC) of 1991 provides that every local government unit (LGU) shall exercise the powers that are essential to the promotion of the general welfare. It shall ensure and support, among other things, promote health and safety, enhancement of economic prosperity and social justice, promote full employment among their residents, and preserve the comfort and convenience of its inhabitants.

Further, Section 17 of the LGC mandates LGUs to exercise such powers and discharge such functions and responsibilities for the efficient and effective provisions of basic services and facilities which includes, among others, roads, buildings and similar facilities to service the needs of its residents.

To fund urgent expenses and projects of the city, a supplemental budget may be enacted when supported by funds actually available as certified by the local treasurer or by new revenue sources (Section 321 of R.A. No. 7160).

The City Treasurer and the City Accountant have issued the Certificate of Availability of Funds as supporting document to the promulgation of a Supplemental Budget.

The City Council likewise approved Resolution No. 1, Series of 2023 of the Executive Committee of the City Development Council, entitled "A RESOLUTION APPROVING THE AMENDMENT OF THE ANNUAL INVESTMENT PROGRAM AND ISSUANCE OF A SUPPLEMENTAL INVESTMENT PROGRAM FOR FY 2023 FOR THE REQUIREMENTS OF THE CITY OF MANILA UNDER PERSONAL SERVICES, MAINTENANCE AND OTHER OPERATING EXPENSES AND CAPITAL OUTLAY IN THE TOTAL AMOUNT OF SEVENTY-FOUR MILLION ONE HUNDRED NINE THOUSAND FIFTY-SEVEN PESOS (PHP. 74,109,057.00).

Be it ordained by the City Council of Manila, in session assembled, THAT:

SECTION 1. Appropriations. – The FY 2023 Supplemental Budget of the City of Manila in the total amount of Seventy-Four Million One Hundred Nine Thousand Fifty-Seven Pesos (PhP. 74,109,057.00) is hereby appropriated to fund the following expenses of the City of Manila, to wit;
