AN ORDINANCE INSERTING A NEW SECTION BETWEEN SECTIONS 19 AND 20 OF ORDINANCE NO. 2411, TO BE KNOWN AS SECTION 19-a RELATIVE TO THE FEES FOR PLUMBING PERMIT, AND ANOTHER NEW SECTION BETWEEN SECTIONS 113 AND 114 OF SAID ORDINANCE NO. 2411, TO BE KNOWN AS SECTION 113-a REGARDING FEES FOR PLUMBING INSPECTION.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. A new section is hereby inserted between Sections 19 and 20 of Ordinance No. 2411, to be known as Section 19-a relative to fees for plumbing permit, which shall read as follows:

"Sec. 19-a. FEES.- (1) There shall be collected for every application of plumbing permit for the installation of a unit composed of 1 water closet, 2 floor drains, 1 sink, 1 lavatory, 2 faucets and 1 showerhead, a fee of P10.00.

(2) For every fixture in excess of a unit, the following fees shall be collected:

(a)	For 1 water closet .....	P 2.00
(b)	" 1 floor drain .....	1.00
(c)	" 1 sink .....	1.00
(d)	" 1 lavatory .....	2.00
(e)	" 1 faucet .....	.50
(f)	" 1 showerhead .....	.50
(g)	" 1 sleep sink .....	2.00
(h)	" 1 urinal .....	1.00
(i)	" 1 bath tub .....	2.00
(j)	" 1 grease trap .....	2.00
(k)	" 1 garage trap .....	1.00
(l)	" 1 bidet .....	1.00
(m)	" 1 filter .....	.50
(n)	" 1 dental cuspidor .....	1.00
(o)	" 1 gas heater .....	1.00
(p)	" 1 hot water boiler .....	1.00
(q)	" 1 drinking fountain .....	.50
(r)	" 1 laundry tray .....	1.00
(s)	" 1 bar or some fountain sink .....	1.00
(t)	" 1 laboratory sink .....	1.00
(u)	" 1 stabilizer .....	.50
(v)	" 1 water meter .....	.50"

SEC. 2. A new section is also hereby inserted between Sections 113 and 114 of said Ordinance No. 2411, to be known as Section 113-a regarding fees for plumbing inspection, which shall read as follows:

"Sec. 113-a. FEES.- There shall be collected the following fees for plumbing inspections:

- (a) For every inspection of ~~connection~~ of water test ..... 5.00
- (b) For every inspection of ~~water~~ connection to new sewer ..... 2.00
- (c) For every inspection of connection of a single fixtures to the existing installation ..... 1.00
- (d) For every inspection of connection of a group of fixtures of not more than 3 fixtures - any kind to the existing installation ..... 2.00
- (e) For every fixture in excess in the group, any kind ..... .50
- (f) For every inspection of water services only ..... 3.00
- (g) For every inspection special or miscellaneous ..... 3.00."

SEC. 3. This Ordinance shall take effect upon its approval.
