

OF MOTOR VEHICLE REPAIR SHOPS ( ?  
MOTOR VEHICLE REPAIR WORK TO REPORT TO  
THE SERIAL NUMBER OF JEEPS, AUTOMOBILES,  
AND OTHER MOTOR VEHICLES, ORDERED FOR RE-  
CONVERSION OF SAME INTO JITNEYS, AND FOR OTHER

Municipal Board of the City of Manila, that:

SEC. 1. Every owner of motor vehicle repair shop or every person engaged on motor vehicle repair work shall keep a record book as prescribed by the Chief of Police in which he shall enter an accurate account and description, including the serial number, registration certificate number issued by the Department of Public Works, etc., in English or Tagalog, of every automobile, weapon carrier or other motor vehicle together with the name and address of the person or persons ordering the repair and conversion into jitney of such jeep, automobile, weapon carrier or other motor vehicle in his shop.

SEC. 2. Every owner of motor vehicle repair shop or every person engaged on motor vehicle repair work shall, at all times, freely admit the Chief of Police, or his authorized representative, government agents or inspectors, to examine each and every book or record and each and every motor vehicle ordered to be repaired or converted into jitney in his shop for inspection purposes.

SEC. 3. Every owner of motor vehicle repair shop or every person engaged on motor vehicle repair work shall make out and deliver to the Chief of Police, or his authorized representative, on the blank form prescribed by him, before twelve o'clock noon, of each day, a full and correct report of all such business transactions of the day regarding the repair or conversion into jitney as provided in Section 1 hereof.

SEC. 4. Any owner of motor vehicle repair shop or every person engaged on motor vehicle repair work violating any of the provisions of this section shall, upon conviction thereof, be punished by a fine of not less than Twenty-Five Pesos nor more than Two Hundred Pesos, or by imprisonment for not more than six months, or both such fine and imprisonment, for each violation, whether committed by himself personally, or by his agent, clerk, or employee. The license and/or permit issued for the operation of such motor vehicle repair shop shall, at the discretion of the Mayor, be revoked and the business therein conducted ordered closed.

SEC. 5. This ordinance shall take effect upon approval.
