

AN ORDINANCE INSERTING AN ITEM TO BE KNOWN AS NO. 78-A UNDER SECTION 3 OF ORDINANCE NO. 3000, IMPOSING PERMIT FEE ON THOSE BUSINESSES LICENSED AND TAXED UNDER THE CHARTER OF THE CITY OF MANILA; AND AMENDING ITEM NO. 79 UNDER THE SAME SECTION OF SAID ORDINANCE, REFERRING TO THE PAYMENT OF PERMIT FEE IN THE AMOUNT OF FIVE PESOS ON OTHER BUSINESSES, TRADES OR OCCUPATIONS NOT MENTIONED IN THE SAID ORDINANCE EXCEPT THOSE UPON WHICH THE CITY OF MANILA IS NOT EMPOWERED TO LICENSE OR TO TAX, BY ADDING THERETO A PROVISIO EXEMPTING FROM THE PROVISIONS OF THIS ORDINANCE STALL HOLDER WITHIN THE MARKET COMPOUND OR OCCUPANT OF TEMPORARY BOOTHS PAYING MARKET FEES, CARRIAGE, CALESA, CARRONATA, CARRETELA, CART, WAITER, WAITRESS, HOSTESS AND SPECIAL WATCHMAN.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. Another item, to be known as Item 78-A, prescribing the payment of permit fees on businesses licensed and taxed under the Charter of the City of Manila and other laws, is hereby inserted after Item 78 of Section 3 of Ordinance No. 3000 to read as follows:

"78-A. Businesses licensed and taxed under the Charter of the City of Manila and other laws:

a. First class bar	P10.00
b. Second class bar	6.00
c. Theater liquor	10.00
d. First class restaurant liquor	10.00
e. Second class restaurant liquor	6.00
f. First class hotel liquor	10.00
g. Second class hotel liquor	6.00
h. Native wine	5.00
i. Druggist liquor	6.00
j. Grocery liquor	10.00
k. Brewers	20.00
l. Distillers	20.00
m. First class wholesale liquor	15.00
n. Second class wholesale liquor	10.00
o. Third class wholesale liquor	5.00
p. Employment agency	10.00
q. General merchandise	5.00"

SEC. 2. Item No. 79 under Section 3 of Ordinance No. 3000 is hereby amended to read as follows:

"79.- All other businesses, trades or occupations not mentioned in this Ordinance, except those upon which the City is not empowered to license or to tax P5.00; PROVIDED, That stall holder within the market compound or occupant of temporary booths paying market fees, carriage, calesa, carronata, carretela, cart, waiter, waitress, hostess and special watchman are exempted from the provisions of this Ordinance; PROVIDED, HOWEVER, That permits issued after June 30th of each year shall be charged for at fifty per centum of the prescribed annual rates; PROVIDED, FURTHER, That nothing herein shall be construed as abrogating or repealing the provisions of other ordinances prescribing license fees for the operation of any business or the exercise of any trade or oc-


cupation, or for the inspection of machinery or other equipment: PROVIDED, FINALLY, That in case of change of the ownership or location of business, it shall be the duty of the owner, agent or manager of such business to secure a new permit and pay the corresponding permit as in the case of a new business."


SEC. 3. - This Ordinance shall take effect upon its approval.




