

AN ORDINANCE GIVING THE NAMES OF "PALTOK", "KALINISAN", "MAGANDA", "MASAYA", "MITHI", "LIGAYA" AND "KASAMA" TO THE SEVEN (7) PROPOSED STREETS WITHIN THE PUREZA SUBDIVISION OF C. M. HOSKINS & CO., INC., SITUATED ON CALLE STA. MESA, SAMPALOC, CITY OF MANILA.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The names of "Paltok", "Kalinisan", "Maganda", "Masaya", "Mithi", "Ligaya", and "Kasama", are hereby given to the seven (7) proposed streets within the Pureza Subdivision of C. M. Hoskins & Co., Inc., situated on Calle Sta. Mesa, Sampaloc, City of Manila, to wit:

PALTOK - This is a private street Southwest of and parallel to the Manila Railroad Right of Way, extending from Calle Kalinisan to Sta. Mesa Bridge in the District of Sampaloc, with an entire length of approximately 600.00 meters.

KALINISAN - This is a private street which forms part of Pureza Extension, extending from Calle Sta. Mesa to Estero de Valencia in the District of Sampaloc, with a length of approximately 400.00 meters.

MAGANDA - This is a private street Northeast of and parallel to Calle Kalinisan extending from Calle Sta. Mesa to Calle Mithi in the District of Sampaloc, with a length of approximately 230.00 meters.

MASAYA - This is a private street Northeast of and parallel to Calle Maganda, extending from Calle Sta. Mesa to Calle Paltok in the District of Sampaloc, with a length of approximately 185.00 meters.

MITHI - This is a private street which forms part of Lardizabal Extension, extending from Calle Kalinisan to Calle Paltok in the District of Sampaloc, with a length of approximately 60.00 meters.

LIGAYA - This is a private street Northwest of and parallel to Calle Sta. Mesa, extending from Calle Masaya to Calle Paltok in the District of Sampaloc, with an entire length of approximately 220.00 meters.


KASAMA - This is a private street Northwest of and parallel to Calle Ligaya, extending from Calle Masaya to Calle Paltok in the District of Sampaloc, with a length of approximately 115.00 meters.


SEC. 2. This Ordinance shall take effect upon its approval.
