

AN ORDINANCE AMENDING SECTION ONE OF ORDINANCE No. 2980, IMPOSING A LICENSE FEE ON THE BUSINESS OF DEALERS ON MOTOR VEHICLES AND ACCESSORIES, AND ON ACCESSORIES AND SPARE PARTS (NEW ONLY), AS AMENDED BY ORDINANCE No. 3046.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. Section 1 of Ordinance No. 2980, as amended by Ordinance No. 3046, is hereby further amended to read as follows:

"SECTION 1. License fee. - No person, entity or corporation shall engage in, exercise, or carry on the trade or business of a dealer (a) on motor vehicles (jeeps, automobiles and trucks and other kinds of machines, such as tractors, roadrollers, bulldozers, trailers, cranes, plow-machines, fork-lift and accessories and spare parts) and (b) on accessories and spare parts (new only) without first having obtained a license to do so. Such license shall be issued by the City Treasurer who is authorized to charge and receive therefor as license fee the following amount based on the actual quarterly gross sales and receipts of the business during a calendar quarter on the last day thereof or immediately thereafter as possible but not later than the 25th of the first month of the quarter next immediately following, as scheduled below:

(a) On the sale of motor vehicles and accessories and spare parts.




