

AN ORDINANCE GIVING THE NAMES OF "KANLURAN", "MALAYA", "SILANGANAN", "BANAAG AT SIKAT", "MULING PAGSILANG", "TALIBA", "KALAKAL", "ROSARIO NICASIO", "TEODORO KALAW", "GRAL. VICENTE LIM", "SIMEON DE JESUS" AND JOSEFA LLANES ESCODA" TO THE TWELVE (12) PROPOSED STREETS IN THE NORTH BALUT SUBDIVISION (COCOMO ISLAND), TONDO, OWNED BY THE C. M. HOSKINS & CO., INC.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The names of "Kanluran", "Malaya", "Silanganan", "Banaag at Sikat", "Muling Pagsilang", "Taliba", "Kalakal", "Rosario Nicasio", "Teodoro Kalaw", "Gral. Vicente Lim", "Simeon de Jesus" and "Josefa Llanes Escoda", are hereby given to the twelve (12) proposed streets in the North Balut Subdivision (Cocomo Island), Tondo, owned by the C. M. Hoskins & Co., Inc. to wit:

1. Kanluran - This is a private 14-meter street, southwest of and parallel to North Bay Boulevard, extending from North Bay Boulevard in a general westerly southerly and easterly direction for a distance of approximately 270 meters to North Bay Boulevard, District of Tondo;
2. Malaya - This is a private 10-meter street, southeast of and parallel to Kalakal Street, northeast of and parallel to North Bay Boulevard and northwest of and parallel to the proposed circumferential Road, extending from the Josefa Llanes Escoda Street in a general southwesterly, southeasterly and northeasterly direction for a distance of about 900 meters to the Simeon de Jesus Street, in the District of Tondo;
3. Silanganan - This is a private 10-meter street, northwest of and parallel to Calle Banaag at Sikat extending from Calle Banaag at Sikat to Calle Malaya, District of Tondo, with a distance of 70 meters, more or less;
4. Banaag at Sikat - This is a private 10-meter street southwest of and parallel to the Josefa Llanes Escoda Street, extending from Calle Malaya, District of Tondo, with a distance of approximately 200 meters;
5. Muling Pagsilang - This is a private 10-meter street northeast of and parallel to the Josefa Llanes Escoda street, extending from Calle Kalakal to Calle Gral. Vicente Lim, District of Tondo, with a distance of about 130 meters;
6. Taliba - This is a private 14-meter street, northeast of and parallel to Calle Muling Pagsilang, extending from Simeon de Jesus Street to the City limit, District of Tondo, with a distance of 160 meters, more or less;


7. Kalakal - This is a private 18-meter street northwest of and parallel to Calle Malaya, extending from North Bay Boulevard to the City limit, District of Tondo, with a distance of approximately 230 meters;
8. Rosario Nicasio - This is a private 18-meter street within the territory of Navotas, Rizal;
9. Teodoro Kalaw - This is a private 18-meter street northwest of and parallel to Calle Kanluran extending from North Bay Boulevard to Estero without name, District of Tondo, with a distance of about 100 meters;
10. Gral. Vicente Lim - This is a private 10-meter street northwest of and parallel to the Simeon de Jesus Street to the City Boundary, District of Tondo, with a distance of 240 meters, more or less;
11. Simeon de Jesus - This is a private 18-meter street northwest of and parallel to Calle Malaya, extending from North Bay Boulevard to the City boundary, District of Tondo, with a distance of approximately 530 meters;
12. Josefa Llanes Escoda - This is a private 18-meter street southwest of and parallel to Calle Maling Pagsilang, extending from Simeon de Jesus Street to the City limit, District of Tondo, with a distance of about 280 meters.


SEC. 2. This Ordinance shall take effect upon its approval.


