

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱430,000.00 TO BE MADE AVAILABLE FOR THE PAYMENT OF SALARY DIFFERENTIALS OF THE MAYOR, VICE-MAYOR, COUNCILORS AND OTHER EXECUTIVE OFFICIALS AS PROVIDED FOR UNDER REPUBLIC ACT NO. 3899, COVERING THE PERIOD FROM JULY 1, 1964 TO JUNE 30, 1965, AND OF THE CITY FISCAL, ASSISTANT CITY FISCALS AND ASSISTANT FISCALS PURSUANT TO THE PROVISION OF REPUBLIC ACT NO. 3537, CORRESPONDING TO THE PERIOD FROM JUNE 20, 1963 TO JUNE 30, 1965.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of ₱430,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the payment of salary differentials of the Mayor, Vice-Mayor, Councilors and other Executive Officials as provided for under Republic Act No. 3899, covering the period from July 1, 1964 to June 30, 1965, and of the City Fiscal, Assistant City Fiscals and Assistant Fiscals pursuant to the provision of Republic Act No. 3537, corresponding to the period from June 20, 1963 to June 30, 1965, itemized as follows:
