

AN ORDINANCE APPROPRIATING THE AMOUNT OF P400,000.00 TO BE MADE AVAILABLE FOR THE PURCHASE OF SUPPLIES AND MATERIALS AND REPAIR OF EQUIPMENT AND MACHINERIES IN THE DEPARTMENT OF PUBLIC SERVICES; UNDER CERTAIN CONDITIONS.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P400,000.00, or so much thereof as may be necessary, is hereby appropriated out of any funds existing in the City Treasury not otherwise appropriated to be made available for the purchase of supplies and materials and for the repair of equipment and machineries in the Department of Public Services, itemized as follows (broken down in a list submitted by the City Public Service Officer, dated October 27, 1964):

PROVIDED, HOWEVER, That the City Public Service Officer shall submit to His Honor, the Mayor and the Municipal Board a list of all supplies and materials purchased, as well as a statement of accounts of the repair of equipment and machineries, together with the receipt numbers and the amounts involved therein, not later than April 15, 1965: PROVIDED, FINALLY, That funds herein appropriated shall be released on quarterly basis, to cover the last three quarters.

SEC. 2. This Ordinance shall take effect as of November 1, 1964.
