AN ORDINANCE AUTHORIZING THE CREATION OF CERTAIN POSITION-ITEMS IN THE OFFICE OF THE CITY ASSESSOR, EFFECTIVE AS OF SEPTEMBER 16, 1964; APPROPRIATING THE AMOUNT OF P110,250.00 NEEDED FOR THE PAYMENT OF THE SALARIES OF SAID POSITIONS AND FOR OTHER PURPOSES.

Be it ordained by the Municipal Board of the City of Manila, that:




SEC. 3. This Ordinance shall take effect as of September 16, 1964.
