

AN ORDINANCE APPROPRIATING THE AMOUNT OF P200,000.00 TO BE MADE AVAILABLE FOR THE CONSTRUCTION AND IMPROVEMENT OF THE EXTENSION OF OROQUIETA STREET, BETWEEN TECSON AND BULACAN STREETS, STA. CRUZ (P30,000.00); ACQUISITION OF 779.3 SQUARE METERS OF LAND BELONGING TO JUSTICE J. B. L. REYES AND DR. EDMUNDO REYES AT THE PRICE OF P150.00 PER SQUARE METER (P116,895.00); PAYMENT OF COMPENSATION TO OWNERS OF IMPROVEMENTS THEREIN ERECTED AND AFFECTED BY THE EXTENSION OF SAID STREET (P15,580.00) AS RECOMMENDED BY THE APPRAISAL COMMITTEE, AND FOR MISCELLANEOUS AND INCIDENTAL EXPENSES (P37,525.00); AND FOR OTHER PURPOSES.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P200,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the construction and improvement of the extension of Oroquieta Street, between Tecson and Bulacan streets, Sta. Cruz; acquisition of 779.3 square meters of land belonging to Justice J. B. L. Reyes and Dr. Edmundo Reyes at the price of P150.00 per square meter; payment of compensation to owners of improvements therein erected and affected by the extension of said street as recommended by the Appraisal Committee, and for miscellaneous and incidental expenses, itemized as follows:

1. For the construction and improvement of the extension of Oroquieta Street, between Tecson and Bulacan streets	P30,000.00
2. For the acquisition of road right-of-way with an area of 779.3 square meters at P150.00 per square meter	116,895.00
3. For the payment of compensation to owners of improvements affected	15,580.00
4. For miscellaneous and incidental expenses	37,525.00

PROVIDED, That the owners of the improvements affected by the extension of said street may be given the salvaged materials of their respective houses: PROVIDED, FURTHER, That they shall undertake the demolition and removal of their improvements at their own expense.

SEC. 2. This Ordinance shall take effect upon its approval.

Originally enacted by the Municipal Board of the City of Manila on February 17, 1965 and modified on April 21, 1965; recalled on April 27, 1965 and enacted anew at its regular session today, December 28, 1965.
