

AN ORDINANCE APPROPRIATING THE AMOUNT OF P94,000.00 TO BE MADE AVAILABLE FOR CERTAIN IMPROVEMENTS IN ARELLANO HIGH SCHOOL.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P94,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the following improvements in Arellano High School.

| 1) Placing of 3.00 meter wide reinforced concrete "media agua", to be supported by 4-inch diameter steel pipes, on the ground floor of the Home Economics Building | P13,000.00 |
| 2) Enlarging the rooms of the ground floor of same Home Economics Building by removing existing hollow-block wall separating the rooms from the corridor and placing instead 6" x 6" x 12" ceramic hollow-block wall along the outer posts. Tool rooms and cabinets must also be provided in this added space | 12,000.00 |
| 3) Installing "media agua" (1.20 meter wide) of steel frames and G.I. roofing for second and third floors of same Home Economics Building | 13,000.00 |
| 4) Placing asbestos sun baffles on E. Alonso side of same Home Economics Building | 13,200.00 |
| 5) Replacing poorly finished floor slabs of the second and third floors of same Home Economics Building with cement tiles | 15,000.00 |
| 6) Construction of a stage (complete with proper lighting and sound system facilities) at the north end of our existing gymnasium building | 12,000.00 |
| 7) Replacing permanent glass windows of said gymnasium building with awning-type steel-framed windows | 14,000.00 |
| 8) Installing steel accordion doors for the three entrances to said gymnasium building | 800.00 |
| 9) Repair of broken glass windows of the vocational and Home Economics Building | 3,000.00 |
| 10) Raising the hollow-block fence facing the estero by one meter | 10,000.00 |
