

AN ORDINANCE APPROPRIATING THE AMOUNT OF P5,800.00 TO BE MADE AVAILABLE FOR THE PURCHASE OF OFFICE FURNITURE AND EQUIPMENT FOR BRANCH XXI OF THE COURT OF FIRST INSTANCE OF MANILA, PRESIDED OVER BY JUDGE JUAN O. REYES.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P5,800.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the purchase of office furniture and equipment for Branch XXI of the Court of First Instance of Manila, presided over by Judge Juan O. Reyes, itemized as follows:
