

AN ORDINANCE APPROPRIATING THE AMOUNT OF P6,000,000.00 TO BE MADE AVAILABLE FOR THE COMPLETION AND EQUIPPING OF ARSENIO H. LACSON MEMORIAL HOSPITAL, UNDER CERTAIN TERMS AND CONDITIONS; AND FOR OTHER PURPOSES.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P6,000,000.00, or so much thereof as may be necessary, is hereby appropriated out of any balances of accounts and/or funds existing in the City Treasury not otherwise appropriated to be made available for the completion and equipping of Arsenio H. Lacson Memorial Hospital, itemized as follows:

- 1. For the purchase of mechanical and electrical equipment; for landscaping and fencing; for construction of driveways, parking lot, doctors' quarters and nurses' quarters; and for maintenance ... P3,500,000.00
  - 2. For the purchase of miscellaneous medical and allied equipment ..... 2,500,000.00
- Total - P6,000,000.00

SEC. 2. Should the funds mentioned in Section 1 hereof be not sufficient or available for the purpose herein indicated, the Mayor is hereby authorized to negotiate and contract on an installment or deferred payment plan for the completion and equipping of Arsenio H. Lacson Memorial Hospital, subject to the following terms and conditions:

- a. That the amortization or installment payments shall not extend beyond twenty years;
- b. That the interests and other bank charges, including any bank guarantee that may be required, shall not exceed 8% per annum of the principal obligations; and
- c. That the contract or award shall be made through public bidding.

SEC. 3. The Committee on Award shall, within six (6) months from the opening or inauguration of Lacson Memorial Hospital, submit to the Office of the Mayor, the Office of the Municipal Board and to the Office of the Vice-Mayor and Presiding Officer of said Body the list of equipment so acquired and/or purchased, including amounts paid or to be paid therefor.

SEC. 4. This ordinance shall take effect upon its approval.
