

AN ORDINANCE ACCEPTING THE OFFER OF THE SUPERIOR MAINTENANCE SERVICES TO PROVIDE JANITORIAL, SANITATION AND MAINTENANCE SERVICES IN THE MAHARNILAD AND THE CITY COURT BUILDING, UNDER CERTAIN CONDITIONS, AND APPROPRIATING FUNDS NEEDED THEREFOR.

WHEREAS, the Superior Maintenance Services, in a letter dated October 21, 1965, offered to provide janitorial, sanitation and maintenance services in the Maharnilad and the City Court building at the monthly rate of P17,000.00, or a total of P204,000.00 annually. The work embraced in the offer consists of furnishing all labor, equipment, supplies and materials and of performing all operations on a seven-day-week basis; and

WHEREAS, it was stated in the report that the yearly appropriation for janitorial services for the cleaning of the Maharnilad reaches to about P364,548.45 per annum as against P204,000.00 per annum offered by the Superior Maintenance Services: Now, therefore

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The offer of the Superior Maintenance Services to provide janitorial, sanitation and maintenance services in the Maharnilad and the City Court building is hereby accepted: PROVIDED, HOWEVER, That all such janitorial, sanitation and maintenance services shall be performed under the supervision of the City Public Service Officer.

SEC. 2. The work included in this offer shall consist of the furnishing of all labor, equipment, supplies and materials and performing all operations on a seven-day-week basis.

SEC. 3. For the protection and interest of the city government, the following shall be required of the Superior Maintenance Services:

1. A performance bond in the amount of P100,000.00, in the form of surety bond acceptable to His Honor, the Mayor;
2. All laborers and technicians to be employed shall be bonded in favor of the City to answer for all losses, damages and destruction of public properties in the Maharnilad and the City Court building arising from the negligence or misdemeanor on the part of the personnel of the Contractor;
3. The Superior Maintenance Services shall be liable for all damages that may be sustained by the City by reason of the former's failure to properly maintain the cleanliness of the Maharnilad and the City Court building, due to strike on the part of its personnel and/or employees, or incapacity arising from other causes: PROVIDED, HOWEVER,

That in case of any disruption in the cleaning and maintenance service, the City is hereby authorized to undertake the work and charge the cost thereof to the account of the Contractor.

SEC. 4. The present personnel composing the janitorial services in the Department of Public Services shall be deployed, transferred or re-assigned to other jobs within the same department.

SEC. 5. The amount of P204,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the payment of the janitorial, sanitation and maintenance services in the Maharnilad and the City Court building to be rendered by the Superior Maintenance Services.

SEC. 6. The City Fiscal shall prepare the contract to be entered into by the City Government and the Superior Maintenance Services, embodying the principal terms and conditions provided for in this ordinance, for a period of one (1) year, renewable for a like or longer period, at the option of the City of Manila which shall be represented by the Office of the Mayor: PROVIDED, HOWEVER, That the terms and conditions of the renewed contract shall first be ratified by the Municipal Board.

SEC. 7. This Ordinance shall take effect upon its approval.

Originally enacted by the Municipal Board of the City of Manila on January 25, 1966, vetoed by His Honor, the Mayor on February 7, 1966, modified by said Body last March 16, 1966 and today, March 29, 1966.
