

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱6,864,251.00 TO BE MADE AVAILABLE FOR CERTAIN PURPOSES IN THE MANILA POLICE DEPARTMENT, UNDER CERTAIN CONDITIONS.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of ₱6,864,251.00, or so much thereof as may be necessary, is hereby appropriated from any surplus, balances of accounts no longer needed and other unappropriated funds existing in the City Treasury, starting with the fiscal year 1965-66, for the following purposes in the Manila Police Department:

- A. For the construction of a 7-storey MPD Facility Building which will house among others the Traffic Control Bureau, Communications Division, Inter-City Radio Network, MPD Academy, MPD Motor Pool and MPD Gymnasium: PROVIDED, HOWEVER, That the winning bidder shall be a qualified licensed building contractor .. ₱5,000,000.00
- B. For the acquisition of the following equipment and supplies and creation of new positions urgently needed by the police force to improve its effectiveness and protective services:

1. Acquisition of scientific, technical and communication equipment & supplies	₱1,230,251.00	
2. Improvement of photo laboratory and polygraph room .	10,000.00	
3. Creation of the following position items to replace policemen performing clerical and other non-police work at ₱2400 p.a. each:		
Seven (7) Photographers		
Ten (10) Fingerprint Technicians		
Fifteen (15) Property Clerks		
Three (3) Statistical Clerks		
Three (3) Radio Technicians		
Six (6) Teletype Technicians		
Twenty (20) Drivers		
Sixty (60) Prison Guards		
One Hundred Thirty (130) Clerks		
Four (4) Radio Dispatchers		
Two (2) Laboratory Helpers		
Total number of positions .. 260 ..	624,000.00	1,864,251.00

SEC. 2. The Mayor shall submit, not later than December 31,

1966, to the offices of the Municipal Board and of the Vice-Mayor and Presiding Officer a written report containing the following information:

- a) The manner in which this ordinance has been implemented - whether the project has been undertaken by administration or through public bidding;
- b) If by administration, the number of the resolution or ordinance authorizing the same;
- c) If through public bidding, the provision of the contract relative thereto;
- d) A statement that the construction conforms with the plans and specifications;
- e) Amount of disbursements and the date and number of the journal voucher covering each disbursement; and
- f) Balance of the fund, if any.

SEC. 3. This Ordinance shall take effect upon its approval.

Originally enacted by the Municipal Board of the City of Manila on September 30, 1965 and modified by said Body at its special session held on March 18, 1966 and at its regular session today, May 24, 1966.

Section 2 above, which is hereby declared for being officious, improper and of doubtful validity.
