

AN ORDINANCE APPROPRIATING THE AMOUNT OF P3,211,383.00 TO BE MADE AVAILABLE FOR THE MAINTENANCE AND OPERATION OF ADDITIONAL CLASSES IN THE HIGH SCHOOLS AND IN THE INTERMEDIATE GRADES IN THE CITY OF MANILA FOR THE SCHOOL YEAR 1966-67.

WHEREAS, the President of the Philippines, in a recent decision, sustained the appeal made by the Municipal Board on the latter's resolution authorizing the Superintendent of City Schools to open new elementary schools, additional secondary, intermediate, night academic and vocational classes in the City of Manila which may be needed at the opening of schools in July, 1966; to hire classroom teachers and other personnel needed therefor, and to purchase needed classroom furniture and equipment, pending the approval of the proposed ordinance appropriating the necessary funds for the purpose, on the condition that no funds shall be used for the opening of Grade VII in the public schools: Now, therefore

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P3,211,383.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the maintenance and operation of additional classes in the high schools and in the intermediate grades in the City of Manila for the school year 1966-67, itemized as follows:


1. Five Hundred Fifty (550) Teachers at P3300- P3600 per annum each	P1,897,500.00
2. Twenty-four (24) Clerks at P2760 p.a. each	66,240.00
3. Eighty (80) Janitor-Guards at P2640 p.a. each ..	211,200.00

8. Two (2) Teachers at P7.00 a night, three nights a week	1,428.00
9. One (1) Librarian at P7.00 a night, three nights a week	714.00
10. For the opening of additional classes in the Evening Vocational Schools and Gregorio Perfecto Vocational High School	160,000.00


SEC. 2. This ordinance shall take effect as of July 1, 1966.
