AN ORDINANCE APPROPRIATING THE AMOUNT OF P940,000.00 TO BE MADE AVAILABLE FOR THE IMPROVEMENT AND CEMENT-PAVING OF CERTAIN STREETS IN THE FIRST DISTRICT OF MANILA, UNDER CERTAIN CONDITIONS.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P940,000.00, or so much thereof as may be necessary, is hereby appropriated out of any surplus, balances of accounts no longer needed or any other funds existing in the City Treasury not otherwise appropriated, to be made available for the improvement and cement-paving of the following streets in the First District of Manila:

subject to the following conditions:

1. That the project herein authorized shall be undertaken thru public bidding which shall be held only upon prior and proper certification by the City Treasurer as to the availability of the total appropriation of funds for this purpose;
2. That any excess in the amount herein appropriated shall, upon the completion of the project, revert to the general fund;
3. That no additional appropriation shall be requested and/or approved for this particular undertaking and/or for extra work;
4. That copies of the contract or contracts entered into pursuant to the provisions of this Ordinance shall be furnished the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body before any work on the project shall be started;
5. That the contractor or contractors to whom aforesaid contract or contracts may be awarded shall not employ non-residents of the City of Manila; and
6. That the City Engineer shall submit to the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body a report on the implementation of this measure not later than December 31, 1966.

SEC. 2. This Ordinance shall take effect upon its approval.

Enacted by the Municipal Board of the City of Manila at its regular session today, September 14, 1966.

Approved by His Honor, the Mayor on September 23, 1966, conditional 1 to 6 above, which are hereby vetoed for being impractical and contrary to the Public Interest
