

AN ORDINANCE APPROPRIATING THE AMOUNT OF P7,582.00 TO BE MADE AVAILABLE FOR THE ACQUISITION OF MUCH-NEEDED DENTAL AND MEDICAL EQUIPMENT FOR THE MEDICAL SERVICES OF JOSE P. LAUREL HIGH SCHOOL IN TONDO.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P7,582.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the acquisition of much-needed dental and medical equipment of the medical services of Jose P. Laurel High School in Tondo, itemized as follows:
