AN ORDINANCE APPROPRIATING THE AMOUNT OF P912,000.00 TO BE MADE AVAILABLE FOR THE CEMENT-PAVING OF CERTAIN STREETS IN THE FIRST DISTRICT OF MANILA.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P912,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the cement-paving of the following streets in the First District of Manila:

1. Tioco Street, from Herbosa Street to Franco Street..	P66,000.00
2. Mayhaligue Street, from A. Rivera Street to J. Abad Santos Street .....	97,000.00
3. J. Abad Santos Street, from Moriones Street to Lakandula Street .....	50,000.00
4. Rodriguez Street, from Estero de Sunog Apog to Estero de Vitas .....	264,000.00
5. Ugbu Street, from Velasquez Street to the Slaughterhouse .....	222,000.00
6. Asta Street, from Franco Street to its dead end ....	41,000.00
7. Francisco Street, from F. Varona Street to Sande Street .....	172,000.00
Total - - - - -	<u>P912,000.00</u>

PROVIDED, HOWEVER, That the project herein authorized shall be undertaken thru public bidding which shall be held only upon prior and proper certification by the City Treasurer as to the availability of the total appropriation of funds for this purpose; that any excess in the amount herein appropriated shall, upon the completion of the project, revert to the general fund; that no additional appropriation shall be requested and/or approved for this particular undertaking and/or for extra work; that copies of the contract or contracts entered into pursuant to the provisions of this Ordinance shall be furnished the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body before any work on the project shall be started; that the contractor or contractors to whom aforesaid contract or contracts may be awarded shall not employ non-residents of the City of Manila; and that the City Engineer shall submit to the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body a report on the implementation of this measure not later than December 31, 1966.

SEC. 2. This Ordinance shall take effect upon its approval.

Enacted by the Municipal Board of the City of Manila at its regular session today, November 17, 1966.

Approved by His Honor, the Mayor on *December 1, 1966* subject to the provision which is hereby set forth for being imposed, *imposition unnecessary, justified and/or contrary to the Revised Charter of Manila.*
