

AN ORDINANCE APPROPRIATING THE AMOUNT OF P1,000,000.00 TO BE MADE AVAILABLE FOR THE COMPLETE CONSTRUCTION OF A PLAYGROUND AT THE CORNER OF ROXAS BOULEVARD AND HERBOSA STREET, TONDO, INCLUDING THE CEMENT-PAVING, LANDSCAPING, FENCING AND INSTALLATION OF ELECTRIC LIGHTS AND FOR THE ACQUISITION OF PLAYGROUND EQUIPMENT AND FACILITIES NEEDED THEREFOR.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P1,000,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the complete construction of a playground at the corner of Roxas Boulevard and Herbosa Street, Tondo, including the cement-paving, landscaping, fencing and installation of electric lights and for the acquisition of playground equipment and facilities needed therefor: PROVIDED, HOWEVER, That the project herein authorized shall be undertaken thru public bidding which shall be held only upon prior and proper certification by the City Treasurer as to the availability of the total appropriation of funds for this purpose; that any excess in the amount herein appropriated shall, upon the completion of the project, revert to the general fund; that no additional appropriation shall be requested and/or approved for this particular undertaking and/or for extra work; that copies of the contract or contracts entered into pursuant to the provisions of this Ordinance shall be furnished the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body before any work on the project shall be started; that before the execution of aforesaid contract or contracts, the Social Welfare Officer shall first be consulted for possible recommendations; that the contractor or contractors to whom aforesaid contract or contracts may be awarded shall not employ non-residents of the City of Manila; and that the City Engineer shall submit to the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body a report on the implementation of this measure not later than December 31, 1966.

SEC. 2. This Ordinance shall take effect upon its approval.

Originally enacted by the Municipal Board of the City of Manila on July 20, 1966 and modified at its regular sessions held on August 10, 1966 and on November 11, 1966.
