

AN ORDINANCE APPROPRIATING THE AMOUNT OF P1,231,000.00 TO BE MADE AVAILABLE FOR THE IMPROVEMENT, INCLUDING THE CONSTRUCTION OF CURBS AND GUTTERS, INSTALLATION OF DRAINAGE FACILITIES AND CEMENT-PAVING, OF CERTAIN STREETS IN THE THIRD DISTRICT OF MANILA.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P1,231,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the improvement, including the construction of curbs and gutters, installation of drainage facilities and cement-paving, of the following streets in the Third District of Manila:

1. Ma. Cristina Street, from Maria Clara Street to Sobriedad Street	P. 293,000.00
2. Nadelco Street, from Nagtahan Street to end of street	97,000.00
3. Pureza Street, from San Jose Street to Anonas Street	260,000.00
4. Reposo Street, from Magsaysay Boulevard to Valenzuela Street	108,000.00
5. Rio Vista Street, from River Street to J. P. Laurel, Sr. Street	20,000.00
6. Rodriguez Arias Street, from J. P. Laurel, Sr. to Barcaiztegui Street	117,000.00
7. Ram tri ram Street, from San Antonio Street to Sor Petronila Street	17,000.00
8. Selamisim Street, from Kalinga Street to San Juan River	108,000.00
9. San Anton Street, from Ram tri ram Street to Bustillos Street	61,000.00
10. Sta. Teresita Street, from Legarda Street to Guevara Street	150,000.00
T o t a l -----	<u>P1,231,000.00</u>

PROVIDED, HOWEVER, That the project herein authorized shall be undertaken thru public bidding which shall be held only prior and proper certification by the City Treasurer as to the availability of the total appropriation of funds for this purpose; that any excess in the amount herein appropriated shall, upon the completion of the project, revert to the general fund; that no additional appropriation shall be requested and/or approved for this particular undertaking and/or for extra work; that copies of the contract or contracts entered into pursuant to the provisions of this ordinance shall be furnished the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body before any work on the project shall be started; that the contractor or contractors to whom aforesaid contract or contracts may be awarded shall not employ non-residents of the City of Manila; and that the City Engineer shall submit to the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body a report on the implementation of this measure not later than December 31, 1966.

SEC. 2. This ordinance shall take effect upon its approval.
