

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱1,325,000.00 TO BE MADE AVAILABLE FOR THE IMPROVEMENT, INCLUDING THE CONSTRUCTION OF CURBS AND GUTTERS, INSTALLATION OF DRAINAGE FACILITIES AND CEMENT-PAVING, OF CERTAIN STREETS IN THE FOURTH DISTRICT OF MANILA.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of ₱1,325,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the improvement, including the construction of curbs and gutters, installation of drainage facilities and cement-paving, of the following streets in the Fourth District of Manila:

1. Buffalo Street, from Zobel Roxas Street to north dead end	₱150,000.00
2. Madre Perla Street, from Zobel Roxas Street to north dead end	80,000.00
3. Teodoro Kalaw Street, from Roxas Boulevard to San Marcelino Street	200,000.00
4. Kansas Street, from San Andres Street to north end of the street	405,000.00
5. Oregon Street, from Taft Avenue to General Luna Street	130,000.00
6. Padre Faure Street, from Roxas Boulevard to San Marcelino Street	150,000.00
7. Pasaje Rosario, from Herran Street to end of the street	14,000.00
8. Romero Salas Street, from Roxas Boulevard to Dakota Street	77,000.00
9. San Pascual Street, from San Andres Street to Vermont Street	71,000.00
10. Sandejas Street, from Vito Cruz Street to the city limits	48,000.00

PROVIDED, HOWEVER, That the project herein authorized shall be undertaken thru public bidding which shall be held only upon prior and proper certification by the City Treasurer as to the availability of the total appropriation of funds for this purpose; that any excess in the amount herein appropriated shall, upon the completion of the project, revert to the general fund; that no additional appropriation shall be requested and/or approved for this particular undertaking and/or for extra work; that copies of the contract or contracts entered into pursuant to the provisions of this Ordinance shall be furnished the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body before any work on the project shall be started; that the contractor or contractors to whom aforesaid contract or contracts may be awarded shall not employ non-residents of the City of Manila; and that the City Engineer shall submit to the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body a report on the implementation of this measure not later than December 31, 1966.

SEC. 2. This Ordinance shall take effect upon its approval.
