

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱1,942,000.00 TO BE MADE AVAILABLE FOR THE IMPROVEMENT, INCLUDING THE CONSTRUCTION OF CURBS AND GUTTERS, INSTALLATION OF DRAINAGE FACILITIES AND CEMENT-PAVING, OF CERTAIN STREETS IN THE THIRD AND FOURTH DISTRICTS OF MANILA.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of ₱1,942,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the improvement, including the construction of curbs and gutters, installation of drainage facilities and cement-paving of the following streets in the Third and Fourth Districts of Manila:

1. Bataan Street, from Leyte Street to Cordillera Street	₱ 240,000.00
2. Bohol Street, from the end of street to G. Tuazon Street	315,000.00
3. Cataluña Street, from Lepanto Street to Andalucia Street	235,000.00
4. Crisostomo Street, from R. Florentino Street to A. Bonifacio Street	255,000.00
5. Dalisay Street, from San Juan River to Lubiran Street	180,000.00
6. Alhambra Street, from T. Kalaw Street to Arquiza Street	65,000.00
7. Almacenas (Int.) Street, from Maestranza Street to Cabildo Street	11,000.00
8. Amadeo Street, from Zulueta Street to Ulilang Kawayan Street	15,000.00
9. I. Claudio Street, from Beata Street to the end of street	125,000.00
10. I. Claudio Street, from end of street to Mindoro Street	8,000.00
11. Del Pilar Street, from P. Nuñez Street to Cagayan Street	80,000.00
12. Echabelita Street, from Mindoro Street to Oregon Street	10,000.00
13. Eden Street, from A. de las Alas Street to Herran Street	24,000.00
14. Enrique Street, from Zobel Roxas Street to Vito Cruz Street	46,000.00
15. Felina Street, from Union Street to Santiago Street	49,000.00
16. Legaspi Street, from San Francisco Street to Beaterio Street	82,000.00
17. Leona Street, from A. Mabini Street to M. H. del Pilar Street	16,000.00
18. Leroy Street, from Trece de Agosto Street to San Gregorio Street	41,000.00
19. Magallanes Street, from Recoletos Street to Postigo Street	145,000.00

PROVIDED, HOWEVER, That the project herein authorized shall be undertaken thru public bidding which shall be held only upon prior and proper certification by the City Treasurer as to the availability of the total appropriation of funds for this purpose; that any excess in the amount herein appropriated shall, upon the completion of the project, revert to the general fund; that no additional appropria-

tion shall be requested and/or approved for this particular undertaking and/or for extra work; that copies of the contract or contracts entered into pursuant to the provisions of this ordinance shall be furnished the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body before any work on the project shall be started; that the contractor or contractors to whom aforesaid contract or contracts may be awarded shall not employ non-residents of the City of Manila; and that the City Engineer shall submit to the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body a report on the implementation of this measure not later than December 31, 1966.

SEC. 2. This ordinance shall take effect upon its approval.
