AN ORDINANCE APPROPRIATING THE AMOUNT OF P162,000.00 TO BE MADE AVAILABLE FOR THE IMPROVEMENT, INCLUDING THE CONSTRUCTION OF CURBS AND GUTTERS, INSTALLATION OF DRAINAGE FACILITIES, ELEVATION TO FLOOD CONTROL LEVEL AND CEMENT-PAVING, OF CERTAIN STREETS IN THE SECOND DISTRICT OF MANILA.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P162,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the improvement, including the construction of curbs and gutters, installation of drainage facilities, elevation to flood control level and cement-paving, of the following streets in the Second District of Manila:

- 1. Clavel Street, from Camba Street to dead end ..... P 57,000.00
- 2. Sto. Cristo Street, from Lavezares Street to San Fernando Street ..... 105,000.00
- T o t a l ----- P162,000.00

PROVIDED, HOWEVER, That the project herein authorized shall be undertaken thru public bidding which shall be held only upon prior and proper certification by the City Treasurer as to the availability of the total appropriation of funds for this purpose; that any excess in the amount herein appropriated shall, upon the completion of the project, revert to the general fund; that no additional appropriation shall be requested and/or approved for this particular undertaking and/or for extra work; that copies of the contract or contracts entered into pursuant to the provisions of this ordinance shall be furnished the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body before any work on the project shall be started; that the contractor or contractors to whom aforesaid contract or contracts may be awarded shall not employ non-residents of the City of Manila; and that the City Engineer shall submit to the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body a report on the implementation of this measure not later than February 28, 1967.

SEC. 2. This ordinance shall take effect upon its approval.

Enacted by the Municipal Board of the City of Manila at its regular session today, January 19, 1967.

Approved by His Honor, the Mayor on *February 3, 1967* *upon the basis above which is hereby noted for being proposed, projects unnecessary, unjustified and/or contrary to the provisions of the Charter of Manila.*
