

AN ORDINANCE APPROPRIATING THE AMOUNT OF P2,554,000.00 TO BE MADE AVAILABLE FOR THE IMPROVEMENT, INCLUDING THE CONSTRUCTION OF CURBS AND GUTTERS, INSTALLATION OF DRAINAGE FACILITIES AND CEMENT-PAVING, OF CERTAIN STREETS IN THE FOURTH DISTRICT OF MANILA.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P2,544,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the improvement, including the construction of curbs and gutters, installation of drainage facilities and cement-paving, of the following streets in the Fourth District of Manila:

1. Villa Pancho Street, from U. N. Avenue to J. Batute Street .....	P 9,000.00
2. Solana Street, from Victoria Street to Aduana Street .....	340,000.00
3. Sto. Sepulcro Street, from Harrison Boulevard to Paz Street .....	112,000.00
4. Sto. Niño Street, from end of street to Beata Street .....	55,000.00
5. Sta. Clara Street, from Havana Street to Lamayan Street .....	65,000.00
6. San Pedro Street, from Remedios Street to Tennessee Street .....	55,000.00
7. Sta. Clara Street, from Arzobispo Street to Cabildo Street .....	35,000.00
8. San Marcelino Street, from San Andres Street to Herran Street .....	325,000.00
9. San Luis Street, from Hilum Street to Jesus Street .....	96,000.00
10. San Juan de Letran Street, from Real Street to Beaterio Street .....	62,000.00
11. 1st Street, from Omaha Street to Muelle del Codo .....	187,000.00
12. 3rd Street, from R. R. Street to Muelle del Codo .....	260,000.00
13. 4th Street, from 7th Street to Muelle del Codo .....	226,000.00
14. 6th Street, from Omaha Street to Tacoma Street .....	85,000.00
15. 7th Street, from R. R. Street to Tacoma Street .....	227,000.00
16. 9th Street, from R. R. Street to Chicago Street .....	135,000.00
17. 10th Street, from R. R. Street to San Francisco Street .....	280,000.00

PROVIDED, HOWEVER, That the project herein authorized shall be undertaken thru public bidding which shall be held only upon prior and proper certification by the City Treasurer as to the availability of the total appropriation of funds for this purpose; that any excess in the amount herein appropriated, shall, upon the completion of the project, revert to the general fund; that no additional appropriation shall be requested and/or

approved for this particular undertaking and/or for extra work; that copies of the contract or contracts entered into pursuant to the provisions of this ordinance shall be furnished the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body before any work on the project shall be started; that the contractor or contractors to whom aforesaid contract or contracts may be awarded shall not employ non-residents of the City of Manila; and that the City Engineer shall submit to the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body a report on the implementation of this measure not later than December 31, 1966.

SEC. 2. This ordinance shall take effect upon its approval.
