

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱1,932,000.00 TO BE MADE AVAILABLE FOR THE IMPROVEMENT, INCLUDING THE CONSTRUCTION OF CURBS AND GUTTERS, INSTALLATION OF DRAINAGE FACILITIES AND CEMENT-PAVING, OF CERTAIN STREETS IN THE THIRD DISTRICT OF MANILA.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of ₱1,932,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the improvement, including the construction of curbs and gutters, installation of drainage facilities and cement-paving, of the following streets in the Third District of Manila:

1. Alfredo Street, from Maria Clara Street to Dapitan Street	₱65,000.00
2. Antonio Street, from Dapitan Street to Andalucia Street	50,000.00
3. Adelina Street, from Quezon Boulevard to Andalucia Street	82,000.00
4. Alcantara Street, from Isabel Street to Gov. Forbes Street	70,000.00
5. Algeciras Street, from G. Tuazon Street to Dimasalang Street	920,000.00
6. Bataan Street, from the end of street to G. Tuazon Street	145,000.00
7. Batanes Street, from the end of street to G. Tuazon Street	280,000.00
8. Betina Street, from the end of street to G. Tuazon Street	140,000.00
9. Calamba Street, from Blumentritt Street to Antipolo Street	180,000.00

T o t a l - - - - - ₱1,932,000.00

PROVIDED, HOWEVER, That the project herein authorized shall be undertaken thru public bidding which shall be held only upon prior and proper certification by the City Treasurer as to the availability of the total appropriation of funds for this purpose; that any excess in the amount herein appropriated shall, upon the completion of the project, revert to the general fund; that no additional appropriation shall be requested and/or approved for this particular undertaking and/or for extra work; that copies of the contract or contracts entered into pursuant to the provisions of this Ordinance shall be furnished the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body before any work on the project shall be started; that the contractor or contractors to whom aforesaid contract or contracts may be awarded shall not employ non-resi-

dents of the City of Manila; and that the City Engineer shall submit to the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body a report on the implementation of this measure not later than January 31, 1967.


SEC. 2. This Ordinance shall take effect upon its approval.
