

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱1,990,000.00 TO BE MADE AVAILABLE FOR THE IMPROVEMENT, INCLUDING THE CONSTRUCTION OF CURBS AND GUTTERS, INSTALLATION OF DRAINAGE FACILITIES AND CEMENT-PAVING, OF CERTAIN STREETS IN THE THIRD AND FOURTH DISTRICTS OF MANILA.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of ₱1,990,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the improvement, including the construction of curbs and gutters, installation of drainage facilities and cement-paving, of the following streets in the Third and Fourth Districts of Manila:

1. Eloisa Street, from Andalusia Street to Quezon Boulevard .....	₱105,000.00
2. Gastambide Street, from Legarda Street to Lepanto Street .....	135,000.00
3. Firmeza Street, from Calabash Road to M. de La Fuente Street .....	145,000.00
4. M. Jhocson Street, from Legarda Street to G. Tuazon Street .....	90,000.00
5. F. Jhocson Street, from Gov. Forbes Street to Sulucan Street .....	115,000.00
6. Josefina Street, from España Street to Laong-Laan Street .....	82,000.00
7. Iardizabal Street, from Pureza Street to Bustillos Street .....	250,000.00
8. Lepanto Street, from Matimyas Street to P. Leoncio Street .....	70,000.00
9. Dian Street, from Vito Cruz Street to Arellano Avenue .....	160,000.00
10. Florida Street, from F. Balagtas Street to Laura Street .....	58,000.00
11. Hilum Street, from Narciso Street to T. San Luis Street .....	45,000.00
12. Indiana Street, from San Andres Street to Herran Street .....	295,000.00
13. Nebraska Street, from San Andres Street to T. Kalaw Street .....	400,000.00
14. Peñafracia Street, from Sagat Street to Herran Street .....	40,000.00
Total - - - -	<u>₱1,990,000.00</u>

PROVIDED, HOWEVER, That the project herein authorized shall be undertaken thru public bidding which shall be held only upon prior and proper certification by the City Treasurer as to the availability of the total appropriation of funds for this purpose; that any excess in the amount herein appropriated shall, upon the completion of the project, revert to the general fund;


that no additional appropriation shall be requested and/or approved for this particular undertaking and/or for extra work; that copies of the contract or contracts entered into pursuant to the provisions of this Ordinance shall be furnished the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body before any work on the project shall be started; that the contractor or contractors to whom aforesaid contract or contracts may be awarded shall not employ non-residents of the City of Manila; and that the City Engineer shall submit to the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body a report on the implementation of this measure not later than December 31, 1966.


SEC. 2. This Ordinance shall take effect upon its approval.

Enacted by the Municipal Board of the City of Manila at its regular session today, December 6, 1966.


Approved by His Honor, the Mayor on February 2, 1967 except the proviso above which is hereby vetoed for being improper, impractical, unnecessary, unjustified and/or contrary to the Revised Charter of Manila.
