

AN ORDINANCE APPROPRIATING THE AMOUNT OF P2,112,000.00 TO BE MADE AVAILABLE FOR THE IMPROVEMENT, INCLUDING THE CONSTRUCTION OF CURBS AND GUTTERS, INSTALLATION OF DRAINAGE FACILITIES AND CEMENT-PAVING, OF CERTAIN STREETS IN THE FOURTH DISTRICT OF MANILA.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P2,112,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the improvement, including the construction of curbs and gutters, installation of drainage facilities and cement-paving, of the following streets in the Fourth District of Manila:

1. South Avenue, from Tejeron Street to Vito Cruz Street	P460,000.00
2. Postigo Street, from Solana Street to West Gate Street	130,000.00
3. Railroad Street, from 25th Street to 11th Street	360,000.00
4. Real Street, from Muralla Street to Sta. Lucia Street	530,000.00
5. Recoletos Street, from Muralla Street to Cabildo Street	86,000.00
6. Rein Street, from Aviadores Street to the estero	16,000.00
7. Renaissance Street, from one end to the other end	66,000.00
8. Revellin Street, from Syquia Street to Pasig Line	132,000.00
9. Robles Street, from Soldado Street to R. Sales Street	15,000.00
10. 14th Street, from R. R. Street to Boston Street	155,000.00
11. 15th Street, from R. R. Street to Boston Street	162,000.00

PROVIDED, HOWEVER, That the project herein authorized shall be undertaken thru public bidding which shall be held only upon prior and proper certification by the City Treasurer as to the availability of the total appropriation of funds for this purpose; that any excess in the amount herein appropriated shall, upon the completion of the project, revert to the general fund; that no additional appropriation shall be requested and/or approved for this particular undertaking and/or for extra work; that copies of the contract or contracts entered into pursuant to the provisions of this Ordinance shall be furnished the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body before any work on the project shall

be started; that the contractor or contractors to whom afore-
said contract or contracts may be awarded shall not employ non-
residents of the City of Manila; and that the City Engineer
shall submit to the Offices of the Municipal Board and of the
Vice-Mayor and Presiding Officer of said Body a report on the
implementation of this measure not later than December 31,
1966.

SEC. 2. This Ordinance shall take effect upon its approval.
