

AN ORDINANCE APPROPRIATING THE AMOUNT OF P1,952,000.00 TO BE MADE AVAILABLE FOR THE IMPROVEMENT, INCLUDING THE CONSTRUCTION OF CURBS AND GUTTERS, INSTALLATION OF DRAINAGE FACILITIES AND CEMENT-PAVING, OF CERTAIN STREETS IN THE THIRD DISTRICT OF MANILA.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P1,952,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the improvement, including the construction of curbs and gutters, installation of drainage facilities and cement-paving, of the following streets in the Third District of Manila:

1. Prudencio Street, from Iardizabal Street to Dimasalang Street	P455,000.00
2. Moret Street, from Sulucan Street to España Street	120,000.00
3. Padre Guevara Street, from Geronimo Street to Isabel Street	88,000.00
4. Saklolo Street, from Bagumbayan Street to Biyaya Street	34,000.00
5. M. Santiago Street, from Matinyas Street to Sobriedad Street	44,000.00
6. Watawat Street, from the estero to Mendoza Street	16,000.00
7. Virginia Street, from Paltec Street to Magsaysay Boulevard	60,000.00
8. Miguelin Street, from Iardizabal Extension to Simoun Street	495,000.00
9. Mindanao Street, from Batanes Street to Bohol Street	118,000.00
10. Navarra Street, from Dapitan Street to Andalucia Street	48,000.00
11. Paquita Street, from España Street to Andalucia Street	60,000.00
12. Patato Street, from Bustillos Street to San Anton Street	30,000.00
13. Langit Street, from Laong-Laan Street to Maria Clara Street	34,000.00
14. Iekas Street, from Lubiran Street to Daligay Street	154,000.00
15. Gelinos Street, from Dapitan Street to Andalucia Street	100,000.00
16. General Trias Street, from rotunda to G. Tuazon Street	68,000.00
17. Juaning Street, from Dapitan Street to Andalucia Street	28,000.00
Total - - - -	<u>P1,952,000.00</u>

PROVIDED, HOWEVER, That the project herein authorized shall be undertaken thru public bidding which shall be held only upon prior and proper certification by the City Treasurer as to the availability of the total appropriation of funds for this pur-

pose; that any excess in the amount herein appropriated shall, upon the completion of the project, revert to the general fund; that no additional appropriation shall be requested and/or approved for this particular undertaking and/or for extra work; that copies of the contract or contracts entered into pursuant to the provisions of this Ordinance shall be furnished the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body before any work on the project shall be started; that the contractor or contractors to whom aforesaid contract or contracts may be awarded shall not employ non-residents of the City of Manila; and that the City Engineer shall submit to the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body a report on the implementation of this measure not later than February 28, 1967.

SEC. 2. This Ordinance shall take effect upon its approval.

Enacted by the Municipal Board of the City of Manila at its regular session today, December 28, 1966.

Approved by His Honor, the Mayor on February 17, 1967 except the proviso above which is hereby vetoed for being improper, impractical, unnecessary, unjustified and contrary to the Revised Charter of Manila.
