

AN ORDINANCE APPROPRIATING THE AMOUNT OF P2,001,000.00 TO BE MADE AVAILABLE FOR THE IMPROVEMENT, INCLUDING THE CONSTRUCTION OF CURBS AND GUTTERS, INSTALLATION OF DRAINAGE FACILITIES AND CEMENT-PAVING, OF CERTAIN STREETS IN THE THIRD AND FOURTH DISTRICTS OF MANILA.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P2,001,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the improvement, including the construction of curbs and gutters, installation of drainage facilities and cement-paving, of the following streets in the Third and Fourth Districts of Manila:

1. Ligao Street, from Padilla Street to its dead end	P 11,000.00
2. Macamisa Street, from Tacio Street to its dead end	27,000.00
3. Batas Street, from Katuwiran Street to Katuwiran Street	127,000.00
4. Biaya Street, from Bagumbayan Street to Biaya Street	120,000.00
5. Bonifacio Extension, from Blumentritt Street to the south end	49,000.00
6. Campomanes Street, from Abreu Street to its dead end	20,000.00
7. Gordillera Street, from Lubiran Street to its dead end	68,000.00
8. Dangal Street, from S. J. River to Bagumbayan Street	165,000.00
9. Dos Castillas Street, from Lealtad Street to Aragon Street	425,000.00
10. Don Quigota Street, from Lepanto Street to Aragon Street	485,000.00
11. Isidro Certeza Street, from Beata Street to Jesus Street	112,000.00
12. Churruca Street, from Isaac Peral Street to San Luis Street	25,000.00
13. Colon Street, from Ayala Boulevard to Concepcion Street	19,000.00
14. Embarcadero Street, from Pasig River to Panaderos Street	29,000.00
15. Felix Street, from Kahiles Street to Herran Street	81,000.00
16. Carola Street, from Geronimo Street to Aragon Street ..	238,000.00
Total - - - - -	<u>P2,001,000.00</u>

PROVIDED, HOWEVER, That the project herein authorized shall be undertaken thru public bidding which shall be held only upon prior and proper certification by the City Treasurer as to the availability of the total appropriation of funds for this purpose; that any excess in the amount herein appropriated shall, upon the completion of the project, revert to the general fund; that no additional appropriation shall be requested and/or approved for this particular undertaking and/or for extra work; that copies of the contract or contracts entered into pursuant to the provisions of this ordinance shall be furnished the Offices of the Municipal Board and of the Vice-Mayor


and Presiding Officer of said Body before any work on the project shall be started; that the contractor or contractors to whom aforesaid contract or contracts may be awarded shall not employ non-residents of the City of Manila; and that the City Engineer shall submit to the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body a report on the implementation of this measure not later than February 28, 1967.


SEC. 2. This ordinance shall take effect upon its approval.

Enacted by the Municipal Board of the City of Manila at its regular session today, December 23, 1966.


Approved by His Honor, the Mayor, on February 17, 1967 except the proviso above which is hereby vetoed for being improper, impractical, unnecessary, unjustified and contrary to the Revised Charter of Manila.
