

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱1,477,000.00 TO BE MADE AVAILABLE FOR THE IMPROVEMENT, INCLUDING THE CONSTRUCTION OF CURBS AND GUTTERS, INSTALLATION OF DRAINAGE FACILITIES AND CEMENT-PAVING, OF CERTAIN STREETS IN THE THIRD DISTRICT OF MANILA.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of ₱1,477,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the improvement, including the construction of curbs and gutters, installation of drainage facilities and cement-paving, of the following streets in the Third District of Manila:

1.	Buencamino Street, from the city limits to Sociego Street	₱31,000.00
2.	Prixton Hill Avenue, from the city limits to Sociego Street	31,000.00
3.	Pat. Antonio Street, from P. Sanchez Street to V. Mapa Street	127,000.00
4.	Silencio Street, from the city limits to Magsaysay Boulevard	76,000.00
5.	M. Araullo Street, from C. Arellano Street to Pureza Street	100,000.00
6.	C. Arellano Street, from J. A. Santos Street to Pureza Street	108,000.00
7.	G. Araneta Street, from J. A. Santos Street to C. Arellano Street	27,000.00
8.	M. Arenas Street, from G. Tuazon Street to San Anton Street	31,000.00
9.	Arevalo Street, from G. Tuazon Street to Prudencio Street	155,000.00
10.	Barcaistegui Street, from R. Arias Street to J. P. Laurel, Sr. Street.	60,000.00
11.	Lapidario Street, from Logarda Street to Lardizabal Street	15,000.00
12.	Pifa Street, from B. Tuazon Street to Magsaysay Boulevard	105,000.00
13.	Piling Street, from Quintana Street to Mariano Street	26,000.00
14.	Arlegui (2nd) Street, from Mendiola Street to Quezon Boulevard	585,000.00

PROVIDED, HOWEVER, That the projects herein authorized shall be undertaken thru public bidding which shall be held only upon prior and proper certification by the City Treasurer as to the availability of the total appropriation of funds for this purpose; that any excess in the amount herein appropriated shall, upon the completion of the projects, revert to the general fund; that no additional appropriation shall be requested and/or approved for this particular undertaking and/or for extra work; that copies of the contract or contracts entered into pursuant to the provisions of this Ordinance shall be furnished the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body before any work on the projects shall be started; that the contractor or contractors to whom aforesaid


contract or contracts may be awarded shall not employ non-residents of the City of Manila; and that the City Engineer shall submit to the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body a report on the implementation of this measure not later than February 28, 1967.


SEC. 2. This ordinance shall take effect upon its approval.
