

AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱2,035,000.00 TO BE MADE AVAILABLE FOR THE IMPROVEMENT, INCLUDING THE CONSTRUCTION OF CURBS AND GUTTERS, INSTALLATION OF DRAINAGE FACILITIES AND CEMENT-PAVING, OF CERTAIN STREETS IN THE THIRD DISTRICT OF MANILA.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of ₱2,035,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the improvement, including the construction of curbs and gutters, installation of drainage facilities and cement-paving, of the following streets in the Third District of Manila:

1. Sofia Street, from the estero to Rodriguez Arias Street	₱ 68,000.00
2. Taclo Street, from Florentino Street to Macaraeg Street	27,000.00
3. Victory Street, from the end of street to J.P. Laurel, Sr. Street	13,000.00
4. Simoun Street, from Blumentritt Street to Dimasalang Street	235,000.00
5. Montaña Street, from Alcantara Street to M. Earnshaw Street	86,000.00
6. Matinyas Street, from the city limits to Anzures Street	82,000.00
7. Minerva Street, from Estero Aviles to J. P. Laurel, Sr. Street	22,000.00
8. Manga Avenue, from the end of street to Santol Street	212,000.00
9. Macaraeg Street, from España Street to Pi y Margal Street	107,000.00
10. Lingayen Street, from Layte Street to Bataan Street	100,000.00
11. Ibarra Street, from Blumentritt Street to A. Bonifacio Street	550,000.00
12. Florentino Street, from Macaraeg Street to Gov. Forbes Street	480,000.00
13. First Street, from V. Mapa Street to Bataan Street	32,000.00
14. M. Francisco Street, from Loreto Street to Magaaysay Boulevard	21,000.00
Total - - -	<u>₱2,035,000.00</u>

PROVIDED, HOWEVER, That the project herein authorized shall be undertaken thru public bidding which shall be held only upon prior and proper certification by the City Treasurer as to the availability of the total appropriation of funds for this purpose; that any excess in the amount herein appropriated shall, upon the completion of the project, revert to the general fund; that no additional appropriation shall be requested and/or approved for this particular undertaking and/or for extra work; that copies of the contract or contracts entered into pursuant to the provisions of this ordinance shall be furnished the Office of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body before any work on the project shall be started; that the contractor or contractors to whom aforesaid

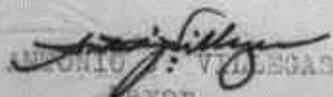
contract or contracts may be awarded shall not employ non-residents of the City of Manila; and that the City Engineer shall submit to the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body a report on the implementation of this measure not later than February 28, 1967.

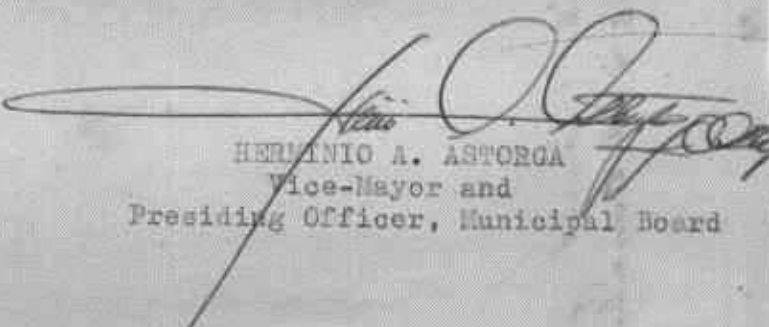
SEC. 2. This ordinance shall take effect upon its approval.
