AN ORDINANCE APPROPRIATING THE AMOUNT OF P858,000.00 TO BE MADE AVAILABLE FOR THE CEMENT-PAVING OF CERTAIN STREETS IN THE FIRST DISTRICT OF MANILA.

No: 181 370

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P858,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the cement-paving of the following streets in the First District of Manila:

1. M. Guizon Street, from Juan Luna Street to Dagupan Street	P 41,000.00
2. Hermosa Extension, from Juan Luna Street to Estero de Sanog Apog	125,000.00
3. Kahanding Street, from Tioco Street to dead end	32,000.00
4. Misericordia Street, from Antipolo Street to Tacson Street	99,000.00
5. Nepomuceno Street, from F. Varona Street to Estero de Vitas	60,000.00
6. P. Ortega Street, from Sto. Cristo Extension to Plaza Leon XIII	29,000.00
7. Padre Rada Street, from Elcano Street to Juan Luna Street	172,000.00
8. Perla Street, from Juan Luna Street to the front of Manuel L. Quezon Elementary School	124,000.00
9. A. C. Herrera Street, from J. T. Santos Street to city limits	138,000.00
10. Tello Street, from Sande Street to Estero de la Reina	39,000.00
Total - - - - -	<u>P858,000.00</u>

PROVIDED, HOWEVER, That the project herein authorized shall be undertaken thru public bidding which shall be held only upon prior and proper certification by the City Treasurer as to the availability of the total appropriation of funds for this purpose; that any excess in the amount herein appropriated shall, upon the completion of the project, revert to the general fund; that no additional appropriation shall be requested and/or approved for this particular undertaking and/or for extra work; that copies of the contract or contracts entered into pursuant to the provisions of this ordinance shall be furnished the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body before any work on the project shall be started; that the contractor or contractors to whom aforesaid contract or contracts may be awarded shall not employ non-residents of the City of Manila; and that the City Engineer shall submit to the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body a report on the implementation of this measure not later than February 28, 1967.

SEC. 2. This ordinance shall take effect upon its approval.
