

AN ORDINANCE AUTHORIZING THE CREATION OF CERTAIN POSITION-ITEMS IN THE PUBLIC BUILDING CONSTRUCTION DIVISION OF THE DEPARTMENT OF ENGINEERING AND PUBLIC WORKS, ALL EFFECTIVE APRIL 1, 1967, UNDER CERTAIN CONDITION; AND APPROPRIATING FUNDS NEEDED THEREFOR.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The creation of the following position-items in the Public Building Construction Division of the Department of Engineering and Public Works, at the rates hereinbelow indicated, all effective April 1, 1967, subject to the provisions of Section 11 of Ordinance No. 5723, is hereby authorized, to wit:

SEC. 3. This Ordinance shall take effect on April 1, 1967.
