AN CRDINANCE APPROPRIATING THE AMOUNT OF P29,000.00 TO BE MADE AVAILABLE FOR THE IMPROVEMENT, INCLUDING THE CONSTRUCTION OF CURBS AND GUTTERS, INSTALIATION OF DRAINAGE AND SEWERAGE FACILITIES, BLEVATION TO FLOOD CONTROL LEVEL AND CEMENT-PAVING, OF P. DEL ROSARIO STREET, FROM D. GOMEZ STREET TO THE CITY BOUNDARY (P18,000.00) AND FROM J. T. SANTOS STREET TO THE ESTERO (P11,000.00) IN THE FIRST DISTRICT OF MANIIA.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of \$29,000.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the improvement, including the construction of curbs and gutters, installation of drainage and sewerage facilities, elevation to flood control level and cement-paving, of P. del Rosario Street, from D. Gomes Street to the city boundary (\$18,000.00) and from J. T. Santos Street to the estero (P11,000.00) in the First District of Manila: PROVIDED, HOWEVER, That the project herein authorized shall be undertaken thru public bidding which shall be held only upon prior and proper certification by the City Treasurer as to the availability of the total appropriation of funds for this purpose; that any excess in the amount herein appropriated shall, upon the completion of the project, revert to the general fund; that no additional appropriation shall be requested and/or approved for this particular undertaking and/or for extra work; that copies of the contract or contracts entered into pursuant to the provisions of this Ordinance shall be furnished the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body before any work on the project shall be started; that the contractor or contractors to whom aforesaid contract or contracts may be awarded shall not employ non-residents of the City of Manila; and that the City Engineer shall submit to the Offices of the Municipal Board and of the Vice-Mayor and Presiding Officer of said Body a report on the implementation of this measure not later than September 30, 1967.

SEC. 2. This Ordinance shall take effect upon its approval.
