AN ORDINANCE APPROPRIATING THE AMOUNT OF ₱195,732.00 TO BE MADE AVAILABLE FOR THE ACQUISITION OF THE PROPERTY OF MR. CONRADO FRANCISCO, KNOWN AS LOT NO. 2-A OF THE SUBDIVISION PLAN PSD-25917, BEING A PORTION OF LOT 2, BLOCK 3803 OF THE CADASTRAL SURVEY OF THE CITY OF MANILA, SITUATED IN THE DISTRICT OF TONDO, CONTAINING AN AREA OF ABOUT 1,087.40 SQUARE METERS, AT A PRICE TO BE AGREED UPON BETWEEN THE OWNER OF THE PROPERTY AND THE TENANTS THEREOF BUT NOT TO EXCEED ₱180.00 PER SQUARE METER, TO BE SUBDIVIDED AND RESOLD TO THE THIRTEEN (13) TENANTS ON SAID PROPERTY IN ACCORDANCE WITH THE PROVISIONS OF ORDINANCE NO. 4709.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of ₱195,732.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the acquisition of the property of Mr. Conrado Francisco, known as Lot No. 2-A of the subdivision plan PSD-25917, being a portion of Lot 2, Block 3803 of the Cadastral Survey of the City of Manila, situated in the District of Tondo, containing an area of about 1,087.40 square meters, at a price to be agreed upon between the owner of the property and the tenants thereof but not to exceed ₱180.00 per square meter, to be subdivided and resold to the following tenants on said property in accordance with the provisions of Ordinance No. 4709:




SEC. 2. This Ordinance shall take effect upon its approval.

Originally enacted by the Municipal Board of the City of Manila on July 14, 1967 and reiterated at its regular session today, September 29, 1967.


