

AN ORDINANCE AUTHORIZING THE SALE OF THE RESIDENTIAL LOTS COMPRISING LOT 90, BLOCK 3008, OWNED BY THE CITY OF MANILA, LOCATED AT STA. MARIA, BALTAZAR AND AMARLANHAGUI STREETS, TONDO, AS SURVEYED BY THE OFFICE OF THE CITY ENGINEER, TO THE ACTUAL AND BONA FIDE TENANTS THEREIN.
