ORDINANCE AUTHORIZING THE ESTABLISHMENT OF A REGULAR BRANCH OF THE CITY LIBRARY IN STA. MESA IN A BUILDING TO BE RENTED FOR THE PURPOSE AND APPROPRIATING THE AMOUNT OF ₱53,550.00 TO BE MADE AVAILABLE FOR ITS INITIAL OPERATION, COVERING THE PERIOD FROM JANUARY 1, 1968 TO JUNE 30, 1968.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The establishment of a regular branch of the City Library in Sta. Mesa in a building to be rented for the purpose is hereby authorized.

SEC. 2. The amount of ₱53,550.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the initial operation of said library, covering the period from January 1, 1968 to June 30, 1968, itemized as follows:


