AN ORDINANCE APPROPRIATING THE AMOUNT OF P20,884.98 TO BE MADE AVAILABLE FOR THE PAYMENT OF THE MONEY VALUE OF THE TERMINAL LEAVES OF THE EMPLOYEES UNDER THE COMPLEMENT OF FORMER COUNCILOR P. REYES CABIGAO.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1.
