AN ORDINANCE AMENDING ORDINANCE NO. 6458, RELATIVE TO THE ACQUISITION OF CERTAIN PARCELS OF LAND LOCATED IN MANOTOK SUBDIVISION, FORMERLY TAMBUNTING ESTATE, TO BE USED AS SITE FOR A TENEMENT HOUSING PROJECT, BY SUBSTITUTING THE PARCELS OF LAND COVERED BY TRANSFER CERTIFICATES OF TITLE NO. 76130 AND 76131 FOR THOSE COVERED BY TRANSFER CERTIFICATES OF TITLE NO. 55124 AND 55127.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. Ordinance No. 6458, relative to the acquisition of certain parcels of land located in Manotok Subdivision, formerly Tambunting Estate, to be used as site for a tenement housing project, is hereby amended to read as follows:

"AN ORDINANCE AUTHORIZING HIS HONOR, THE MAYOR TO INITIATE EXPROPRIATION PROCEEDINGS AGAINST THE MANOTOK SUBDIVISION, FORMERLY KNOWN AS THE TAMBUNTING ESTATE, COVERED BY TRANSFER CERTIFICATES OF TITLE NO. 76130, 55125 AND 76131, ALL ISSUED BY THE REGISTER OF DEEDS OF MANILA, BOUNDED BY RIZAL AVENUE EXTENSION, AURORA BOULEVARD AND THE CHINESE CEMETERY, STA. CRUZ, TO BE USED AS SITE FOR A TENEMENT HOUSING PROJECT, AND SETTING ASIDE THE AMOUNT OF ₱6,000,000.00 TO BE MADE AVAILABLE FOR THE FILING OF THE NECESSARY BOND IN CONNECTION WITH SAID EXPROPRIATION PROCEEDINGS, UNDER CERTAIN CONDITION.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. His Honor, the Mayor is hereby authorized to initiate expropriation proceedings against the Manotok Subdivision, formerly known as the Tambunting Estate, covered by Transfer Certificates of Title No. 76130, 55125 and 76131, all issued by the Register of Deeds of Manila, bounded by Rizal Avenue Extension, Aurora Boulevard and the Chinese Cemetery, Sta. Cruz, to be used as site for a tenement housing project: PROVIDED, HOWEVER, That the present occupants of the property shall be given priority in the allocation of the dwelling units in the tenement housing project to be established.

SEC. 2. The amount of ₱6,000,000.00, or so much thereof as may be necessary, is hereby set aside out of any fund existing in the City Treasury not otherwise appropriated, to be made available for the filing of the necessary bond in connection with the expropriation proceedings authorized in Section 1 hereof.

SEC. 3. This Ordinance shall take effect upon its approval."
