IS APPROPRIATING THE AMOUNT OF P159,005.00 TO BE MADE AVAILABLE FOR THE PAYMENT OF THE AMOUNT DUE MR. JOSE A. SANTOS OF PASIG, RIZAL, FOR THE IMPROVEMENT, PLANTING AND MAINTENANCE OF THE MAIN THOROUGHFARES AND BOULEVARDS OF THE CITY OF MANILA (P123,000.00), INCLUDING THE HIRING OF ONE (1) WATER CART FOR WATERING OF LANDSCAPE PLANTING FOR A PERIOD OF SIX (6) MONTHS (P36,000.00).

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P159,005.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated and existing in the City Treasury to be made available for the payment of the amount due Mr. Jose A. Santos of Pasig, Rizal, for the improvement, planting and beautification of the main thoroughfares and boulevards of the City of Manila, including the hiring of one (1) water cart for watering of landscape planting for a period of six (6) months, itemized as follows:

1. Roxas Boulevard along sea wall, from P. Paredes Street to P. Paredes Street - 147 x P75.00 each (per specification No. 1) P 21,315.00
2. España Street, from P. Paredes Street to common City boundary - 120 x P75.00 each (per specification No. 3) 11,900.00
3. P. United Street, from Ayala Bridge to Pandang Street - 167 x P70.00 each (per specification No. 3) 11,690.00
4. Proposed plantings and improvement on R. Maguway Boulevard which would need 500 bungang china plants complete with low lying flowering plants and garden plants under specification No. 2 at P25.00 each 15,000.00
5. Harrison Boulevard, from East of Lagoon Memorial to East of Roxas Boulevard to Dakota Street - 72 x P75.00 each (per specification No. 2) 5,325.00
6. East Avenue from Ayala Street to San Andres Rotonda - 312 x P75.00 each 30% (per specification No. 2) Note: Only bungang china plants and soil was supplied here 16,380.00
7. Rizal Avenue from Garfield Street to Recto Avenue - 94 x P75.00 each 30% (per specification No. 2) Note: Only bungang china plants and soil were supplied here 4,925.00
8. Villages Fountain Garden - 21 x P70.00 (per specification No. 3) 1,470.00
9. East Avenue from United Nations Avenue to San Andres Rotonda. Note: Garden soil only 1,165 cu. m. x P10.00 per cu. m. 11,650.00
10. Roxas Boulevard from Luneta to Pussy City boundary - 254 x P70.00 (per specification No. 3) Note: The total number of damaged plants was 138. Mr. Santos donated 88 of them. 17,780.00
