AN ORDINANCE APPROPRIATING THE AMOUNT OF P2,571.16 TO BE MADE AVAILABLE FOR THE RENOVATION OF THE MEDICO-LEGAL OFFICE OF THE POLICE DEPARTMENT.

Be it ordained by the Municipal Board of the City of Manila

SECTION 1. The amount of P2,571.16, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the renovation of the Medico-Legal Office of the Manila Police Department, itemized as follows:
