

AN ORDINANCE AUTHORIZING THE RESTORATION OF THE POSITIONS CREATED UNDER RESOLUTIONS NO. 467, 493, 521, 477 AND 538, ALL CURRENT SERIES, AS WELL AS THE RE-INSTATEMENT OF THE SALARY INCREASES OF ITEMS NO. 48, 159, 161, 162 AND 163 IN THE APPROPRIATION OF THE OFFICE OF THE MUNICIPAL BOARD UNDER ORDINANCE NO. 6651, WHICH WERE INADVERTENTLY OMITTED OR REDUCED IN THE APPROPRIATION OF SAID OFFICE FOR THE PRESENT FISCAL YEAR, AND APPROPRIATING FUNDS NEEDED THEREFOR.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The restoration of the following positions created under Resolutions No. 467, 493, 521, 477 and 538, all current series, is hereby authorized:
