

SEC. 3. "NO SMOKING" signs required. - The owner, operator or manager of any of the establishments and conveyances where smoking is prohibited under this ordinance shall post in conspicuous places therein appropriate and legible "No Smoking" signs, or any other similar notices.

SEC. 4. Penalty. - Any person violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be punished by a fine of not more than One Hundred Pesos (P100.00) or by imprisonment of not more than twenty (20) days, or by both such fine and imprisonment in the discretion of the Court.

SEC. 5. Separability clause. - All ordinances or parts thereof inconsistent herewith are hereby repealed or modified accordingly.

SEC. 6. This Ordinance shall take effect sixty (60) days after approval.

AN ORDINANCE PROHIBITING SMOKING IN SPECIFIED PLACES EXCEPT UNDER CERTAIN CONDITIONS, PROVIDING PENALTY FOR VIOLATION THEREOF; AND FOR OTHER PURPOSES.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. Smoking prohibited in specified places except under certain conditions. - No owner, operator or manager of any of the establishments and conveyances herein-below specified shall allow smoking nor shall any person smoke in any of such establishments and conveyances except under the conditions herein after mentioned.

(a) Bars, restaurants, cocktail lounges and other enclosed public eating places unless an exhaust fan or fans or other ventilating devices as certified to be adequate by the Chief, Fire Department and the City Health Officer shall have been provided to insure the elimination of foul air therefrom.

(b) Dancehalls, nightclubs, restaurants or other public places offering facilities for dining and dancing unless an exhaust fan or fans or other ventilating devices as certified to be adequate by the Chief, Fire Department and the City Health Officer shall have been provided to insure the elimination of foul air therefrom: PROVIDED, HOWEVER, That smoking shall be absolutely prohibited on the dance floors thereof regardless of the provision for exhaust fans or other ventilating devices.

(c) Factories, plants and retail stores unless an exhaust fan or fans or other ventilating devices as certified to be adequate by the Chief, Fire Department and the City Health Officer shall have been provided to insure the elimination of foul air therefrom.

(d) Public theaters or motion picture houses, or other auditoria used for such purposes during showing or intermission therein or in any projection booth or enclosure or room in a public place in which any motion picture machine is being operated, except in lobbies and comfort rooms.

(e) Places for storage or carriers of inflammable liquids, explosive and combustible materials, public or private gasoline stations, magazines for explosive, cargo trucks, tank vehicles, or vessels carrying inflammable liquids, explosive or combustible materials.

(f) Inside elevators of any establishment regardless of capacity.

(g) Passenger buses (PUB), jeepneys (PUJ and AC) of any other public conveyances operating in or through the City of Manila, except taxicabs.

SEC. 2. Smoking as used in this ordinance shall include the carrying of lighted cigar, cigarette or pipe or other smoking paraphernalia whether or not it is being puffed, smoked or inhaled.
