

AN ORDINANCE AUTHORIZING THE RESTORATION OF CERTAIN POSITION-ITEMS IN THE DIFFERENT DIVISIONS AND SECTIONS OF THE OFFICE OF THE MUNICIPAL BOARD WHICH WERE TRANSFERRED TO THE DIFFERENT DEPARTMENTS AND OFFICES OF THE CITY GOVERNMENT UNDER ORDINANCE NO. 6651, THE TRANSFER WITH CHANGE IN DESIGNATIONS OF CERTAIN POSITION-ITEMS FROM THE VARIOUS STANDING COMMITTEES OF THE OFFICE OF THE MUNICIPAL BOARD TO THE SESSION HALL OF SAID OFFICE, AND THE RESTORATION OF CERTAIN ABOLISHED POSITION-ITEMS IN THE APPROPRIATION OF THE MUNICIPAL BOARD; AND APPROPRIATING FUNDS NEEDED THEREFOR.
