

AN ORDINANCE APPROPRIATING THE AMOUNT OF P4,24,620.00 TO BE MADE AVAILABLE FOR THE ACQUISITION BY THE CITY OF MANILA OF NINETEEN (19) LOTS BELONGING TO THE AGUS DEVELOPMENT CORPORATION (12 LOTS IN BLOCK 45 AND 7 LOTS IN BLOCK 44), ALL SITUATED IN THE DISTRICT OF SAMPALOC, FOR RESALE TO THE ACTUAL BONA FIDE TENANTS THEREOF, ON EASY INSTALLMENT BASIS, UNDER THE "LAND-FOR-THE TENANTS" PROGRAM OF THE CITY.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P424,620.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated funds or out of the expected additional income from approved revenue-raising measures of the City of Manila to be made available for the acquisition by the City of Manila of nineteen (19) lots belonging to the Agus Development Corporation (12 lots in Block 45 and 7 lots in Block 44), all situated in the District of Sampaloc, for resale to the following actual bona fide tenants thereof, on easy installment basis, under the "Land-for-the-tenants" program of the city:
