

AN ORDINANCE APPROPRIATING THE AMOUNT OF P100,682.00 (P100,212.00 FOR THE LAND AND P470.00 FOR REGISTRATION FEE) TO BE MADE AVAILABLE FOR THE ACQUISITION OF THE PROPERTY OF MISS JOSEFA OCAMPO AND MRS. ARSENIA O. GATUSLAC, DESCRIBED AS LOT NO. 8-A-1 (LRC) PSD-2614 AND LOT NO. 10-A (LRC) PSD-2674, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 71165 OF THE REGISTER OF DEEDS OF THE CITY OF MANILA, CONTAINING AN AGGREGATE AREA OF ABOUT 71.58 SQUARE METERS, AT THE PRICE OF P1,400.00 PER SQUARE METER, AS RECOMMENDED BY THE APPRAISAL COMMITTEE, FOR THE WIDENING OF ILAYA STREET AND M. DE SANTOS STREET, SAN NICOLAS.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P100,682.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the acquisition of the property of Miss Josefa Ocampo and Mrs. Arsenia O. Gatuslao, described as Lot No. 8-A-1 (LRC) Psd-2614 and Lot No. 10-A (LRC) Psd-2674, covered by Transfer Certificate of Title No. 71165 of the Register of Deeds of the City of Manila, containing an aggregate area of about 71.58 square meters, at the price of P1,400.00 per square meter, as recommended by the Appraisal Committee, for the widening of Ilaya Street and M. de Santos Street, San Nicolas, broken down as follows:

1. For the land .....	P100,212.00
2. For the registration fee .....	470.00
<b>T o t a l</b> .....	<b>P100,682.00</b>

SEC. 2. This ordinance shall take effect upon its approval.
