

AN ORDINANCE APPROPRIATING THE AMOUNT OF P6,697.00 (P6,622.00 FOR THE LAND AND P75.00 FOR REGISTRATION EXPENSES) TO BE MADE AVAILABLE FOR THE ACQUISITION BY THE CITY OF THE PROPERTIES OF ELISA DE SANTOS, ET. AL., DESCRIBED AS LOT NO. 136, BLOCK NO. 3008, CONTAINING AN AREA OF ABOUT 74.9 SQUARE METERS WHICH NOW FORMS PART OF CORCUERA STREET, TONDO, AT THE PRICE OF P60.00 PER SQUARE METER, AND LOTS NO. 117 AND 118, BLOCK NO. 3008, CONTAINING AREAS OF ABOUT 19.5 AND 10.9 SQUARE METERS, RESPECTIVELY, WHICH NOW FORM PART OF FRANCISCO STREET, TONDO, AT THE PRICE OF P70.00 PER SQUARE METER, AS RECOMMENDED BY THE APPRAISAL COMMITTEE.

Be it ordained by the Municipal Board of the City of Manila, that:

SECTION 1. The amount of P6,697.00, or so much thereof as may be necessary, is hereby appropriated out of the unappropriated fund existing in the City Treasury to be made available for the acquisition by the city of the properties of Elisa de Santos, et. al., described as Lot No. 136, Block No. 3008, containing an area of about 74.9 square meters which now forms part of Corcuera Street, Tondo, at the price of P60.00 per square meter, and Lots No. 117 and 118, Block No. 3008, containing areas of about 19.5 and 10.9 square meters, respectively, which now form part of Francisco Street, Tondo, at the price of P70.00 per square meter, as recommended by the Appraisal Committee, broken down as follows:

For Lot No. 136	P4,494.00
For Lots No. 117 and 118	2,128.00
For registration expenses for the transfer of Lot No. 136	50.00
For registration expenses for the transfer of Lots No. 117 and 118	25.00
Total - - - - -	<u>P6,697.00</u>

SEC. 2. This ordinance shall take effect upon its approval.
